Land Identifier Type 1 (field 17) and Land Identifier 1 (field 18) cannot be blank.

Land Identifier 1 must have two or more characters.

For 'Other' enter description such as: grant, number, parish number or other alpha numeric description.

For 'Aquaculture' enter a Land Identifier such as: L6011, parcel 17, NE75AQ000, or alpha numeric description in addition to Latitude and Longitude.

The Reported Land Identifier (Legal) must be valid for location state/location county section/township. A legal validation file will be made available via the IP server.
