# **BACKGROUND:**

The Livestock Risk Protection (LRP) Basic Policy was changed to clarify that insurance will not attach if payment is not received on the date insurance coverage is purchased. Additionally, new Farm Bill language on sanctions was added to the Basic Policy.

The Feeder Cattle Specific Coverage Endorsement (SCE) was changed to reflect the name change of the Chicago Mercantile Exchange Group and the corresponding change to the report used for prices.

The LRP Lamb SCE was modified to include the weights of insured lambs.

Producers interested in LRP will need to contact a crop insurance agent and complete an application, which will be submitted through the approved insurance provider to FCIC. The Risk Management Agency (RMA) has published on its website a list of agents authorized by their insurance providers to write livestock insurance.
