SUBJECT: 2009 Crop Year Group Risk Plan Payment Yields for Corn, Soybeans, and Grain Sorghum; 2009 Crop Year Group Risk Income Protection Plan Final County Yields and County Revenues for Corn, Soybeans, and Grain Sorghum

In accordance with Section 3 of the Group Risk Plan (GRP) Crop Provisions, payment yields have been approved for Group Risk Plan Corn, Soybeans, and Grain Sorghum for the 2009 crop year. These payment yields have been incorporated into the Actuarial Data Master and will be available by close of business today on the Risk Management Agency website at: www.rma.usda.gov/data/grpfinal/.

In accordance with Section 3 of the Group Risk Income Protection (GRIP) Plan Crop Provisions, final county yields and county revenues have been approved for Group Risk Income Protection Plan Corn, Soybeans, and Grain Sorghum for the 2009 crop year. These final county yields and county revenues have been incorporated into the Actuarial Data Master and will be available by close of business today on the Risk Management Agency website at: www.rma.usda.gov/data/gripfinal/.

Counties with payment yields, final county yields, or county revenues listed as "TBD" are pending the release of county estimates by the National Agricultural Statistics Service (NASS).

GRP and GRIP policy provisions state that payment yields and final county yields will be determined by RMA based on NASS county estimates. In some situations, NASS has been unable to provide a county estimate for the basis of the GRP or GRIP offer available in that county. In these situations, RMA has utilized either the combined county estimate or, if that does not exist, the combined district estimate provided by NASS as the basis for determining the payment yield or final county yield. The attached list notes which counties with policies are impacted as well as the NASS estimates used as a basis for the payment yields and final county yields.
