SUBJECT: Common Crop Insurance Policy Basic Provisions and Various Crop

Provisions for the 2011 Crop Year

The Risk Management Agency (RMA) has revised the following Common Crop Insurance Policy Basic Provisions and Crop Provisions to incorporate changes made in the Final Rule published in the Federal Register on March 30, 2010:

Common Crop Insurance Policy Basic Provisions (11-BR);

Small Grains Crop Provisions (11-0011);

Malting Barley Price and Quality Endorsement (11-0091b);

Coarse Grains Crop Provisions (11-0041);

Cotton Crop Provisions (11-0021);

Rice Crop Provisions (11-0018);

Canola and Rapeseed Crop Provisions (11-0015); and

Sunflower Seed Crop Provisions (11-0078).

The Common Crop Insurance Policy Basic Provisions and Crop Provisions listed above will replace the Crop Revenue Coverage (CRC), Income Protection (IP), Indexed Income Protection (IIP), and the Revenue Assurance (RA) plans of insurance. The new documents offer producers of certain crops a choice of revenue protection (protection against loss of revenue caused by low prices, low yields or a combination of both) or yield protection (protection for production losses only).

Numerous other revisions have been made in the Common Crop Insurance Policy Basic Provisions, which are effective for the 2011 and succeeding crop years for all crops with a 2011 contract change date on or after April 30, 2010, and for the 2012 and succeeding crop years for all crops with a 2011 crop year contract change date prior to April 30, 2010.

RMA has also revised the following Crop Provisions to make technical corrections and incorporate quality adjustment provisions that were previously contained in an Amendatory **Endorsement:**

Insurance providers must notify policyholders of these changes at least 30 days prior to the cancellation date as required by the contract change section of the policy.
