GRIP and GRIP-HRO Special Provisions for the 2012 crop year state: If NASS is unable to provide a yield used to determine the final county yield on the same basis as the expected county yield described in the actuarial documents, RMA will determine the final county yield.

Irrigated Total / Planted Yield - calculated as the acre-weighted average of 2012 irrigated yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity. If a participant was found to have un-harvested acreage claim(s) in 2012, appraised production from these claims was deducted.
