## **BACKGROUND:**

The Risk Management Agency (RMA) has revised the Arizona-California Citrus Crop Provisions (15-0126) for the 2015 and succeeding crop years. The provisions were revised to: standardize terminology; allow optional units by commodity type if authorized by the Special Provisions; expand insurable causes of loss for fruit damaged by insects and disease (unless damage is due to insufficient or improper application of control measures); and clarify insurability requirements for topworked and grafted trees.

As part of the effort to standardize terminology, the definition of "crop" has been replaced by a definition of "citrus fruit commodity." Under this new definition, some of the "citrus fruit commodities" have been given new designations, which have resulted in several of the previous "crops" being combined under one of the new "citrus fruit commodities." Table 1 lists the previous "crop" names for the 2014 and prior crop years in the first column, while the second column lists the new "citrus fruit commodity" names for the 2015 and succeeding crop years.

The "citrus fruit commodities" have been divided into "citrus fruit groups" through the Special Provisions. The "citrus fruit groups" are now the basis for electing coverage levels and determining the insured crop. The "citrus fruit groups" have been established in order to keep the basis for coverage levels, basic units, and administrative fees for the 2015 and succeeding crop years as similar as possible to the basis for the 2014 and prior crop years. Table 2 lists the "citrus fruit groups" under the new citrus fruit commodities.
