#### **Description of RMA (ARPI) Determinations** (Includes information reported to RMA as of April 9, 2018)

**Total for Crop / Planted Yield -** calculated as the acre-weighted average of 2016 yields reported to RMA as actual yields by crop insurance program participants in the county.

**Irrigated** / **Planted Yield** - calculated as the acre-weighted average of 2016 irrigated yields reported to RMA as actual yields by crop insurance program participants in the county.

**Non-Irrigated / Planted Yield -** calculated as the acre-weighted average of 2016 non-irrigated yields reported to RMA as actual yields by crop insurance program participants in the county.

**Total for Crop / Harvested Yield -** calculated as the acre-weighted average of non-zero 2016 yields reported to RMA as actual yields by crop insurance program participants in the county. If a participant was found to have un-harvested acreage claim(s) in 2016, acreage from these claims was not included.
