Tropical Tree - Bananas Hawaii

Crop Insured

Banana trees are insurable for which a premium rate is provided by the actuarial documents in which you have a share, are grown to produce a crop intended to be sold for human consumption, RMA inspects and approves the orchard, and you provide evidence of at least 4 consecutive crop years of experience growing the crop, excluding year set out.

Tree age will be determined on December 31 according to the following table:

Year	Months After Set Out
1	≤12
2	13 - 24
3	25 - 36
4	37+

Counties Available

Tropical fruits are insurable in Hawaii, Kauai, Honolulu, and Maui counties.

Causes of Loss

You are protected against the following:

- Adverse weather conditions; •
- Destruction of trees, if authorized by the insurance provider to contain the spread of disease;
- Disease, but not damage due to insufficient or improper application of control measures;
- Earthquake; ٠
- Fire, unless weeds and undergrowth are not • controlled;
- Insects or plant disease, but not damage due to insufficient or improper application of control measures;
- Tsunami;

- Volcanic eruption; or
- Wildlife, unless recommended wildlife control measures have not been taken.

Insurance Period

Insurance begins January 1 for carryover policies and 30 days after we receive your application for new policies, but no earlier than January 1. The insurance period ends at the earliest occurrence of one of the following:

- December 31; or
- When we determine the total destruction of the insured trees on the unit.

Coverage Levels and Premium Subsidies

Coverage levels range from 50 to 75 percent of your approved yield. Crop insurance premiums are subsidized as shown in the following table. For example, if you choose the 65-percent coverage level, your premium share would be 41 percent of the base premium.

Catastrophic Risk Protection (CAT) coverage is fixed at 50 percent of your approved yield and 55 percent of the price election. CAT is 100-percent subsidized with no premium cost to you. There is, however, an administrative fee of \$300 per crop per county, regardless of the acreage.

This fact sheet gives only a general overview of the crop insurance program and is not a complete policy. For further information and an evaluation of your risk management needs, contact a crop insurance agent.

Assume 500 banana trees, 75-percent coverage, a reference price of \$36 per tree for growth stage year 2, and 300 trees dead after a hurricane.
