Tropical Tree - Coffee

Hawaii

Crop Insured

Coffee trees are insurable if there is a premium rate provided by the actuarial documents in which you have a share and are grown to produce a crop intended to be sold for human consumption, RMA inspects and approves the orchard, and you provide evidence of at least 4 consecutive crop years of experience growing the crop, excluding year set out.

Tree age will be determined on December 31 according to the following table.

Year	Months After Set Out
1	≤ 12
2	13 - 24
3	25 - 36
4	37+

Counties Available

Tropical fruits are insurable in Hawaii, Kauai, Honolulu, and Maui counties.

Causes of Loss

You are protected against the following;

- Adverse weather conditions;
- Destruction of trees, if authorized by the insurance provider to contain the spread of disease;
- Disease, but not damage due to insufficient or improper application of control measures;
- Earthquake;
- Fire, unless weeds and undergrowth are not controlled:
- Insects or plant disease, but not damage due to insufficient or improper application of control measures;
- Tsunami;
- Volcanic eruption; or

• Wildlife, unless recommended wildlife control measures have not been taken.

Insurance Period

Insurance begins January 1 for carryover policies and 30 days after we receive your application for new policies, but no earlier than January 1. The insurance period ends at the earlier occurrence of one of the following:

- December 31; or
- When we determine the total destruction of the insured trees on the unit.

Coverage Levels and Premium Subsidies

You can select a coverage level ranging from 50 to 75 percent of the maximum value established for the age of the tree. Crop insurance premiums are subsidized as shown in the following table. For example, if you choose the 65-percent coverage level, your premium share would be 41 percent of the base premium.

Item	Percent					
Coverage Level	50	55	60	65	70	75
Premium Subsidy	67	64	64	59	59	55
Your Premium Share	33	36	36	41	41	45

Catastrophic Risk Protection (CAT) coverage is fixed at 50 percent of your approved yield and 55 percent of the price election. CAT is 100-percent subsidized with no premium cost to you. There is, however, an administrative fee of \$300 per crop per county, regardless of the acreage.

Growth Stage Year 1 (Hawaii county)\$18 per tree
Growth Stage Year 2 (Hawaii county)\$21 per tree
Growth Stage Year 3 (Hawaii county)\$29 per tree
Growth Stage Year 4 (Hawaii county)\$42 per tree

Loss Example

Assume 500 coffee trees in Kauai, 75-percent coverage, a reference price of \$11 per tree for growth stage year 2, and 300 trees are dead after a fire.

500 <u>x \$11</u> \$5,500	Total insured trees Tree reference price at stage 2 Value of insured trees
300 <u>x \$11</u> \$3,300	Total dead trees Tree reference price at stage 2 Value of dead trees
3,300	Value of dead trees
÷ 5,500	Value of insured trees
60%	Damage
1.0 - 0.75 25%	Coverage level Deductible
60%	Percent of Established Price
- 25%	Deductible
35%	Loss
\$5,500	Value of insured trees
<u>x 35%</u>	Loss
\$1,925	Indemnity
