SUBJECT: Actuarial Rates Resulting from Unrepaired Levees in Missouri

BACKGROUND

Due to the 2008 flood events, levees along the Grand River in Chariton County, and levees along the Mississippi River in Clark, Lewis, Lincoln, Pike, and St. Charles Counties Missouri, were breached. These breached levees are currently under repair, which is being coordinated by the local levee districts and the United States Army Corp of Engineers. For the upcoming growing season, acreage that is protected by these levees will be more susceptible to future flooding events while levee repairs are being completed. For the 2009 crop year, the following policy provision can be found in the Chariton, Clark, Lewis, Lincoln, Pike and St. Charles County Special Provisions of Insurance (SPOI) for Corn, Grain Sorghum, and Soybeans:

Land flooded due to a breach in a levee resulting from prior year(s) flooding conditions is insurable. The applicable rate will be assigned based on conditions at the sales closing date. This land will be classified as the high risk area classification that results in the highest rate if the levee has not been repaired to prior specifications, or if the soil was damaged and was not restored to at least the same crop yield potential as prior to the flood event. The land will be classified as shown on the Actuarial Map if the levee is repaired to prior specifications and the soil has at least the same crop yield potential as before the flood.

After March 16, 2009 & After Planting	The Highest Map Area rate in the county will be applied to the land located on the accompanying maps as specified by the SPOI statement.	A shapefile illustrating the "Affected Area" on the accompanying maps will be available for download from the RMA website on March 17 th , 2009. In the event a levee district, listed in the above table with an estimated completion date prior to March 16 th , 2009, has not been repaired, updated maps will be generated. DAS will validate acreage reports based on the attached maps and shapefiles.

^{1 -} RMA will consider the breached levees "repaired to prior specifications" when the levees offer equal to or greater than the level of height protection that existed prior to the flood event.
