EXPANSION: None

DELETIONS: None

DATES: The new Northern Potato Provisions establishes the End of Insurance Period for Kansas at 10/25 (see statement changes).

STATEMENTS: The current statement restricting coverage on Double Crop Soybeans was replaced by one that would allow coverage by written agreement in the following counties:

Allen, Barber, Bourbon, Butler, Chautauqua, Clark, Cowley, Comanche, Elk, Greenwood, Harper, Harvey, Kingman, Kiowa, Pratt, Reno, Sedgwick, Sumner, and Woodson.

A similar Double Crop Statement was placed on the SPOIs of following Grain Sorghum counties:

Allen, Barber, Bourbon, Butler, Chautauqua, Cherokee, Clark, Cowley, Comanche, Crawford, Elk, Greenwood, Harper, Harvey, Kingman, Kiowa, Labette, Montgomery, Neosho, Pratt, Reno, Sedgwick, Sumner, Wilson, and Woodson.

Statements referencing the Northern Potato Provisions and the End of Insurance Period were removed from the SPOIs for all Potato counties, as Kansas has been included on the new Northern Potato Provisions.

The End of Insurance Period statement has been removed from the SPOIs for Millet as a result of the new Millet Crop Provisions.

A new price discovery statement has been added to the SPOIs for RA Sunflowers that redefines the Projected Harvest Price and the Fall Harvest Price as well as the discovery period.

High-Risk Land statements have been added to Leavenworth County Oats, Corn, Grain Sorghum, and Soybeans due to the addition of a High-Risk Map.

Quality Discount Tables have been updated for Oats.

The Sorghum Silage SPOI statements regarding record requirements and Insurance Guarantee adjustments have been revised to allow Corn Silage records to be used to meet these requirement on the Irrigated Sorghum Silage practice.

TRANSITIONAL YIELDS: T-yields have been updated for Popcorn.

Millet target rates were increased to account for the impact of the Millet Policy changes.

Changes were made in the premium subsidy factors for all GRIP plans of insurance.

The Millet Crop Provisions have been revised to remove the reduction in the indemnity for Millet that has not been harvested.

The hail exclusion factors have been revised for all crops.
