EXPANSION: Pasture, Rangeland, and Forage (PRF) has been expanded under the Rainfall Index (RI) for Alamosa, Boulder, Chaffee, Clear Creek, Conejos, Costilla, Custer, Denver, Douglas, Eagle, Fremont, Gilpin, Grand, Gunnison, Huerfano, Jackson, Jefferson, Lake, Larimer, Park, Pitkin, Rio Grande, Routt, Saguache, Summit, and Teller Counties.

DELETIONS: GRP, GRIP, and GRIP-HRO Wheat deleted from Elbert and Morgan Counties.

DATES: Several dates have changed for Pasture, Rangeland, and Forage (PRF) and Apiculture (API), under both the Rainfall Index and Vegetation Index. The new dates are listed below. Contract Change Date – June 30 Sales Closing Date – September 30 Acreage Reporting Date – November 15 Cancellation & Termination Date – September 30

STATEMENTS: A new **Apiculture** and **PRF** Statement for all counties under the RI plan that reads, "An insured may select any Index Interval provided in the Special Provisions; however overlapping months are not permitted within a single grid ID and share." The High Risk area statement has been modified for **all crops** in all counties with a high risk map to reflect changes to ITM. The organic farming practice and organic rate factor statements have been removed from **all crops** in all counties. The organic APH (database) statement has been modified for **all crops** in all counties as new practices have been created for organics. The short rate statement has been modified in all counties for **Wheat**. A new summerfallow statement has been added for all **Barley** and **Wheat** counties with the summerfallow practice. A new continuous crop statement has been added for Baca, Bent, Cheyenne, Elbert, Kiowa, Kit Carson, Las Animas, Otero, Prowers, and Pueblo Counties. For **Forage Production**, the statement that makes acreage of alfalfa uninsurable the sixth and succeeding crop year after the year of establishment has been removed. New falling number discount table located in the Quality Statement for **Wheat**. Quality Factors have been updated for all crops.

PRACTICES/TYPES: Organic (certified) and Organic (transitional) are new practices for **Barley**, **Forage Production**, and **Wheat**.
