  - Adjustments to Cov. Level Rate Differential factors and to limit increase in rate to producer.
- Annual adjustments of Reference Rates towards Target Rates for other crops
- Updated high risk land rates for land along Cedar River in counties 011, 013, 031, 113, and 139.

#### STATEMENTS:

- ALL crops with Quality Adjustment on the SPOIs: Discount Factors were updated.
- CORN, GRAIN SORGHUM, SOYBEANS: New quality statements on SPOIs.
- FORAGE SEEDING, GREEN PEAS, HYBRID SEED CORN, and POTATOES: Removed map area 001 and map area factor 1.00 from FCI-35s.
- POTATOES
  - Added statement to SPOIs limiting insurability of "fingerling" type to written agreement only.
  - Changed the high risk land statement in Louisa and Muscatine to one that is appropriate for GYC crops.
- CORN, FORAGE SEEDING, GRAIN SORGHUM, OATS, and SOYBEANS: Added unrated land statement to SPOI in Appanoose County (BBB area changed to ///).

- CORN
  - Updated County T-Yields and map area TYs for APH, CRC, and RA plans(added map area TYs that are lower than the County TYs in 28 counties).

- HYBRID SEED CORN: Updated County Yields based on updated corn T-yields.
