To determine the correct contract price for green peas, the verifier must have a copy of the processor contract for the crop year for which the records have been provided. The tenderometer reading or sieve size used to determine the contract price needed to calculate pounds adjusted for quality is:

Early Season:	115 Tenderometer Reading or #3 Sieve Size
Mid Season:	110 Tenderometer Reading or #4 Sieve Size
Late Season:	110 Tenderometer Reading or #4 Sieve Size

If the variety being grown by the policyholder does not appear on this list, agents should contact their insurance company.
