Barley

Minnesota

Crop Insured

All barley grown in the county is insurable if:

- Grown in the county on insurable acreage;
- Premium rates are provided;
- You have a share; and
- Planted for harvest as grain.

There are four barley specialty types for the “Combo” Plans (01)-(03), and you must report your acreage by the specialty type you have planted. The specialty types are: Malting, Waxy Hulled, Waxy Hulless, and Hulless. If you are not growing any of the specialty types, your barley will be insured under the all others type. Contact a crop insurance agent for details.

Counties Available

See actuarial documents at <http://prodwebnlb.app.rm.usda.gov/apps/ActuarialInformationBrowser2014/CropCriteria.aspx> for insurable counties. The crop may be insurable in other counties by written agreement if specific criteria are met. Contact an insurance agent for more details.

Causes of Loss

You are protected against the following:

- Adverse weather conditions such as natural perils of hail, frost, freeze, wind, drought, and excess moisture;
- Failure of irrigation water supply, if caused by an insured peril during the insurance period;
- Fire, if due to natural causes;
- Plant disease and insects, but not damage due to insufficient or improper application of pest or disease control measures; or
- Wildlife.

Insurance Period

Insurance coverage begins on the later of:

- Date we accept your application; or

- Date when the barley is planted, Insurance coverage ends with the earliest occurrence of one of the following:
- Total destruction of the crop;
- Harvest of the unit;
- Final adjustment of a loss;
- Abandonment of the crop; or
- October 31, 2014.

Reporting Requirements

Acreage Report - You must give a report of all your barley acreage in the county by the acreage reporting date.

Definitions

APH Yield - Actual production history (APH) yield used to determine the production guarantee. The APH yield is based on up to 10 years of actual and/or assigned yields.

Unit - The insurable acreage used to determine the APH yield, the production guarantee, and any indemnity (loss payment).

Production Guarantee - Number of bushels guaranteed per unit. Multiply your APH yield per acre by the coverage level percentage you select by the number of acres in the unit.

High Risk Land (HRL) - Land designated on a map in the actuarial documents with a high risk rate classification, requiring a higher premium rate due to higher risk.

HRL Exclusion Option - An agreement to exclude from crop insurance coverage all high risk land by crop and county. You must submit the signed form by

the sales closing date. Catastrophic Risk Protection (CAT) coverage is still available when this option is in effect.

Coverage Levels and Premium Subsidies

Barley may be insured at the coverage levels shown in the following table. Crop insurance premiums are subsidized as shown. For example, if you select the 75-percent coverage level with an enterprise unit, your coverage is based on 75 percent of your approved APH yield, the premium subsidy is 77 percent, and your premium share is 23 percent of the base premium.

CAT coverage is available only under the Yield Protection Plan at 50 percent of your APH yield and 55 percent of the projected price. The total cost for CAT coverage is an administrative fee of \$300 per crop per county, regardless of the acreage. Administrative fees, in addition to premium costs, for coverage levels above CAT are \$30 per crop per county.

Projected and Harvest Price

Commodity Exchange Price Provisions (CEPP) - Contains information necessary to set the **projected price** and the **harvest price** for the insured crop. Information includes the price discovery period, release dates, board of trade(s) used, and additional pricing information. Contact your agent or go to the RMA website at www.rma.usda.gov.

Unit Division

Basic Unit (BU) - A basic unit includes all of your insurable barley acreage in the county by share arrangement. Premium discounts apply.

Optional Unit (OU) - If a basic unit consists of two or more sections of land, and certain recordkeeping requirements are met, you may apply for optional units by section.

Enterprise Unit (EU) - Generally, all the insured crop acreage in a county. Premium discounts apply.

Whole Farm Unit (WU) - Generally, all the insured crops in the county that are covered by the insurance plan. Premium discounts apply. Does not apply to Yield Protection Plan.

Insurance Plans

One policy provides the choice of three plans:

Yield Protection (01) - Production guarantee based on **individual** yield history. Optional, basic, and enterprise units are available.

Revenue Protection (02) - Revenue protection including price protection with optional, basic, enterprise, and whole farm units.

Revenue Protection with Harvest Price Exclusion (03) - Revenue protection with harvest price exclusion with optional, basic, enterprise, and whole farm units.

Options

Malting Barley Price and Quality Endorsement - Supplemental coverage is available in select counties for malting barley in addition to the coverage provided by the barley crop provisions. Only varieties approved by the American Malting Barley Association or grown under the terms of a malting barley contract will be insurable. Additional premium is charged when this endorsement is selected. This option is not available with CAT coverage.

Replant Provisions

A replanting payment is allowed only if the crop is damaged by a covered cause of loss so the remaining stand will not produce at least 90 percent of your bushel guarantee and it is practical to replant. The maximum replanting payment will be the lesser of 20 percent of the bushel guarantee or 4 bushels, multiplied by the projected price. Replanting payments are not available with CAT coverage.

Late and Prevented Planting

These provisions provide protection on acreage that is planted after the final planting date or that cannot be planted. Please contact a crop insurance agent for details.

Loss Example

Yield Protection Example: A loss occurs when the bushels of barley produced for the unit fall below the production guarantee as a result of damage from a covered cause of loss. This example assumes a 60 bushels per acre APH yield, 70-percent coverage level, and basic unit coverage.

60	Bushels per acre APH yield
<u>x 0.70</u>	Coverage level
42	Bushel guarantee
<u>- 22</u>	Bushels per acre actually produced
20	Bushels per acre loss
<u>x \$4.00</u>	Projected price (announced in March)
\$80.00	Gross indemnity
<u>- \$11.00</u>	Estimated premium per acre (varies)
\$69.00	Net indemnity

Revenue Protection Example:

42	Bushels guarantee (see yield example)
x \$4.00	Projected price (announced in March)
\$168.00	Guarantee
22	Bushels per acre actually produced
x \$3.75	Harvest price (est. - announced in Sept.)
\$82.50	Revenue
\$85.50	Gross indemnity (\$168.00 - \$82.50)
- \$14.00	Estimated premium (varies)
\$71.50	Net indemnity
