Dry Beans

Wisconsin

Crop Insured

All dry beans are insurable if:

- Grown in the county on insurable acreage;
- Premium rates are provided;
- You have a share; and
- Planted for harvest as dry beans.

Other types or practices are not insurable unless by a written agreement.

Counties Available

See actuarial documents at <http://prodwebnlb.app.rm.usda.gov/apps/ActuarialInformationBrowser2015/CropCriteria.aspx> for insurable counties. The crop may be insurable in other counties by written agreement if specific criteria are met. Contact an insurance agent for more details.

Causes of Loss

You are protected against the following:

- Adverse weather conditions such as natural perils of hail, frost, freeze, wind, drought, and excess moisture;
- Failure of irrigation water supply, if caused by an insured peril during the insurance period;
- Fire, if due to natural causes;
- Insects and plant disease, but not damage due to insufficient or improper application of pest or disease control measures; or
- Wildlife.

Insurance Period

Insurance coverage begins on the later of one of the following:

- Date we accept your application; or
- Date when the dry beans are planted,

Insurance coverage ends with the earliest occurrence of one of the following:

- Total destruction of the crop;

- Harvest of the unit;
- Final adjustment of a loss;
- Abandonment of the crop; or
- October 31, 2015.

Reporting Requirements

Acreage Report - You must give a report of all your dry bean acreage in the county by the acreage reporting date.

Definitions

APH Yield - Actual production history (APH) yield used to determine the production guarantee. The APH yield is based on up to 10 years of actual and/or assigned yields.

Unit - The insurable acreage used to determine the APH yield, the production guarantee, and any indemnity (loss payment).

Production Guarantee - Number of pounds guaranteed per unit. Multiply your APH yield per acre by the coverage level percentage you select by the number of acres in the unit.

Coverage Levels and Premium Subsidies

Dry beans may be insured at the coverage levels shown in the following table. Crop insurance premiums are subsidized as shown. For example if you select the 75-percent coverage level, your coverage is 75 percent of your approved APH yield, the premium subsidy is 55 percent, and your premium share is 45 percent of the base premium. Catastrophic Risk Protection (CAT) coverage is available at 50

percent of your APH yield and 55 percent of the established price election. The total cost for CAT coverage is an administrative fee of \$300 per crop per county, regardless of the acreage. Administrative fees, in addition to premium costs, for coverage levels above CAT are \$30 per crop per county.

Price Election

Price of compensation per pound in case of loss:

Dark red kidney \$0.40 per pound
Light red kidney \$0.40 per pound

Unit Division

Basic Unit (BU) - A basic unit includes all of your insurable dry bean acreage in the county by share arrangement. Premium discounts apply.

Optional Unit (OU) - If a basic unit consists of two or more sections of land, and certain recordkeeping requirements are met, you may apply for optional units by section.

Enterprise Unit (EU) - Generally, all the insured crop acreage in a county. Premium discounts apply. Enterprise unit by practice is allowed.

Plans of Insurance

APH is the only plan of insurance available for dry beans. The production guarantee is based on your individual yield history.

Replant Provisions

A replanting payment is allowed only if the crop is damaged by a covered cause of loss to the extent that the remaining stand will not produce at least 90 percent of your production guarantee and it is practical to replant. The maximum replanting payment will be the lesser of 10 percent of the production guarantee or 120 pounds, times your price election, and times your share. No replanting payment will be made on acreage initially planted prior to the earliest planting date. Replanting payments are not available with CAT coverage.

Late and Prevented Planting

These provisions provide protection on acreage that is planted after the final planting date or that cannot be planted. Please contact a crop insurance agent for

details.

Loss Example

A loss occurs when the pounds of dry beans produced for the unit fall below the production guarantee as a result of damage from a covered cause of loss. This example assumes a 1,400 pounds per acre APH yield for light red kidney type, 75-percent coverage level, and basic unit coverage.

1,400	Pounds per acre APH yield
x 0.75	Coverage level
1050	Pound guarantee
- 700	Pounds per acre actually produced
350	Pounds per acre loss
x \$0.40	Price election
\$140.00	Gross indemnity
- \$18.00	Est. producer premium per acre (varies)
\$122.00	Net indemnity

Figures shown on a per acre basis; guarantees and losses paid are on a unit basis. See policy provisions.
