

2017 IOWA ACTUARIAL UPDATE

4/30, 6/30, & 8/31 FILINGS

4/30 IA Programs: LGM – Cattle, Dairy Cattle, Swine; LRP – Fed Cattle, Feeder Cattle, Lamb, Swine

6/30 IA Crops: Corn Margin Protection; Forage Production APH; Soybeans Margin Protection; Combo Wheat

8/31 IA Programs: Pasture/Rangeland/Forage (PRF) Rainfall Index; Whole Farm Revenue Protection (WFRP)

PROGRAM EXPANSIONS:

- Yield Exclusion, 2015 added as eligible yield exclusion year for:
 - FORAGE PRODUCTION APH: Davis, Henry, Jefferson, Keokuk, Van Buren, Wapello, and Washington Counties.
 - WHEAT: Appanoose, Davis, Decatur, Des Moines, Fremont, Henry, Jefferson, Lee, Louisa, Mills, Page, Ringgold, Taylor, Van Buren, Wapello, and Wayne Counties.

PROGRAM DELETIONS: None.

DATES: No changes.

RATES:

- FORAGE PRODUCTION: Rate review completed.
- Some rates for other crops may have changed due to rates moving toward previously established target rates.

STATEMENTS:

- FORAGE PRODUCTION APH and WHEAT: Removed SPOI statement regarding interest accrual on premium amounts or fees owed FCIC.
- FORAGE PRODUCTION APH and WHEAT: Removed SPOI “Practice” statement on separating certified organic and transitional acreage APH databases.
- Removed SPOI statements for all counties/crops on conservation compliance requirements to file an AD-1026 with FSA.
- Removed SPOI unrated statement in **Dubuque** and **Clayton** Counties due to elimination of unrated areas in both counties.
- Removed unrated statements from the Rates Tab for **Dubuque** County and the Maps Tab for **Clayton** County of the Actuarial Information Browser due to elimination of unrated areas in both counties.
- WHEAT: Added text to Section C that expands discount factors for aflatoxin to include “mycotoxins and other” for the edible portion of crops exposed to flood waters.

TYPES/PRACTICES: No changes.

T-YIELDS:

- FORAGE PRODUCTION APH: T-yield review completed.

MAPS:

- Updated actuarial maps filed for Allamakee, Clayton, and Jackson Counties in Northeast Iowa to modify unrated (URA) sub-county boundaries.
- The Dubuque County actuarial map was removed for all crops.
