

2017 MINNESOTA ACTUARIAL UPDATE

4/30, 6/30, & 8/31 FILINGS

4/30 MN Programs: LGM - Cattle, Dairy Cattle, Swine; LRP - Fed Cattle, Feeder Cattle, Lamb, Swine

6/30 MN Crops: Cultivated Wild Rice APH; Forage Production APH & Area Yield Protection (AYP); Grass Seed APH; Wheat Margin Protection

8/31 MN Crops/Programs: Apiculture Rainfall Index; Apples APH; Pasture/Rangeland/Forage (PRF) Rainfall Index; Whole Farm Revenue Protection (WFRP)

PROGRAM EXPANSION:

- Yield Exclusion, 2015 added as eligible yield exclusion year for:
 - Forage Production APH in Benton, Big Stone, Cass, Crow Wing, Grant, Mille Lacs, Morrison, Stearns, Stevens, Todd, Traverse, and Wilkin Counties.

PROGRAM DELETIONS: None.

DATES:

- FORAGE PRODUCTION Area Yield Protection (AYP) filing date was changed from 8/31 to 6/30.

RATES:

- Rate reviews completed for FORAGE PRODUCTION and GRASS SEED.
- Some rates for other crops may have changed due to rates moving toward previously established target rates.

STATEMENTS:

- CULTIVATED WILD RICE, FORAGE PRODUCTION APH, and GRASS SEED – Removed SPOI statement regarding interest accrual on premium amounts or fees owed FCIC.
- CULTIVATED WILD RICE, FORAGE PRODUCTION APH, and GRASS SEED – Removed SPOI “Practice” statement on separating certified organic and transitional acreage APH databases.
- FORAGE PRODUCTION AYP – SPOI “date” statement added to explain that for consented acreage damaged by winterkill to be reported as uninsurable, a revised acreage report must be submitted on or before May 15.
- FORAGE PRODUCTION AYP – removed the rotational grazing statement.
- FORAGE PRODUCTION AYP – modified the conservation compliance statement regarding producers who started farming after June 1 but prior to July 1 (beginning of reinsurance year) may be eligible for the premium subsidy without having form AD-1026 on file with FSA on or before June 1.
- CULTIVATED WILD RICE, FORAGE PRODUCTION APH, and GRASS SEED – Removed SPOI statements for all counties on conservation compliance requirements to file an AD-1026 with FSA.

TYPES/PRACTICES: No changes.

T-YIELDS:

- T-yield reviews completed for FORAGE PRODUCTION and GRASS SEED.

MAPS: Updated Winona County URA Map Areas to align with DNR land.
