Grapes

North Carolina

Crop Insured

Grape varieties grown for wine or juice are insurable if the vines have:

- Reached the fourth growing season after being set out for all Muscadine, native, and hybrid varieties; and
- Produced an average of 2 tons per acre in at least 1 of the 3 most recent crop years.

Grapes grown for fresh market consumption (i.e., table grapes) are not insurable under this policy.

Counties Available

Muscadine grapes are insurable in Bladen and Sampson counties. Native and hybrid varieties are insurable in Surry County. Grapes in other counties, including Vinifera grapes, may be insurable by written agreement if specific criteria are met. Contact a crop insurance agent for more details.

Causes of Loss

You are protected against the following:

- Adverse weather conditions, including hail, frost, freeze, wind, drought, and excess precipitation;
- Failure of irrigation water supply, if caused by an insured peril during the insurance period;
- Fire caused by an insured peril during the insurance period;
- Insect damage and plant disease, except for insufficient or improper application of control measures; or
- Wildlife.

Insurance Period

Coverage begins on November 21, 2016, and ends with the earliest occurrence of one of the following:

- Total destruction of the crop;
- Harvest of the crop;
- Final adjustment of a claim;

- Abandonment of the crop; or
- November 20, 2017.

Sales Closing Date November 20, 2016
Acreage/Production Report Date ... January 15, 2017
Premium Billing Date August 15, 2017

Duties in the Event of Damage or Loss

Notice of Loss - If a loss occurs notify your crop insurance agent:

- Within 72 hours of initial discovery of damage;
- If you previously gave notice of crop damage, you must also provide notice at least 15 days before the beginning of harvest to claim an indemnity; or
- At least 3 days before the date harvest should have started if the crop will not be harvested.

Coverage Levels and Premium Subsidies

Coverage levels range from 50 to 85 percent of your average yield (5-percent increments) and are subsidized as shown in the table below.

Catastrophic Risk Protection (CAT) coverage is fixed at 50 percent of your average yield and 55 percent of the price election. The cost for CAT coverage is an administrative fee of \$300.

Price Elections

Coverage levels and price election percentages vary by grape type. The price used to determine your indemnity on unharvested acreage is the price election minus the harvest cost (\$100/ton). For price elections

Insurable Varieties

The native insurable varieties are Muscadine, Niagara, Concord, Catawba, Elvira, Dutchess, Isabella, Diamond, Delaware, Ives, Golden Muscat, Labrusca, and all other natives. The hybrid insurable varieties are Chambourcin, Traminette, Baco Noir, Geneva Red 7, Dechaunac, Rosette, Seyval Blanc, Vignoles, Aurore, Cayuga White, Vidal Blanc, Vincent, Chardonel, Cascade, Leon Millot, Chancellor, Valvin Muscat, Castel, Colobel, Rougeon, Villard Blanc, Melody, Noiret, Chelois, St Vincent, Marechal Foch, Corot Noir, Landot Noir, and all other hybrids.

Loss Example

Assume Muscadine variety with an approved yield of 4 tons per acre, 65-percent coverage level, Non-irrigated, 100-percent share, and a one-acre basic unit.
