Crop Insurance Deadline Nears in New York

Growers with Spring-Planted Crops Need to Make Insurance Decisions Soon

RALEIGH, N.C., February 17, 2017 – The USDA’s Risk Management Agency (RMA) reminds New York growers that the final date to apply for crop insurance coverage on most spring-planted crops for the 2017 crop year is March 15, 2017. Current policyholders who wish to make changes to their existing policies also have until March 15 to do so.

Crop insurance provides protection against crop production losses due to natural perils such as drought, hail, and excessive moisture. Coverage for cabbage, corn, dry beans, forage seeding, fresh market beans, fresh market sweet corn, grain sorghum, green peas, potatoes, processing beans, processing sweet corn, processing tomatoes, soybeans, spring barley, and spring oats is available in select counties. Coverage is also available for revenue losses caused by a change in the harvest price from the projected price for corn, grain sorghum, soybeans, and spring barley.

Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2017 crop year, including insurance for cabbage, corn, dry beans, forage seeding, fresh market beans, fresh market sweet corn, grain sorghum, green peas, potatoes, processing beans, processing sweet corn, processing tomatoes, soybeans, spring barley, and spring oats, which may be eligible for coverage under a written agreement. Crop insurance coverage decisions must be made on or before the sales closing date.

Crop insurance is sold and delivered solely through private crop insurance agents. A list of crop insurance agents is available at all USDA Service Centers and online at the RMA [Agent Locator](#).
