Attached are the Reference Year Adjustment Factors (RYAF) for the contract seed dry peas and the contract seed dry beans. All actual and assigned yields must be factored to their 2014 equivalent value. This attachment is pertinent to agents, verifiers, and adjustors; please distribute as necessary for your operation.

Refer to the [FCIC 18010] Crop Insurance Handbook Exhibit 14A(5) and Exhibit 14F for specific instructions on APH determinations. **Reminder:** When Transitional yields (T-yields) are needed to complete the four-year minimum APH database or when constructing the Yield Floor value or YA Yield Substitution, T-yields must first be factored to the current year's equivalent. The double asterisk (\*\*) designates which year's RYAF is to be used in adjusting the current year's T-Yield (2014) for standard T-Yield variable percentages or yield floor computations. The double asterisk RYAF is also used in determining YA yield substitution values for qualifying low yields occurring in 2003 and subsequent years.

For low actual yields in years 2002 and prior that are eligible for YA, remember the T-yields contained within the actuarial documents for 2002 and prior years are expressed in 1987-dollar equivalents. Use the RYAF designated with the single asterisk (\*) to derive the corresponding years' T-yield in its 2014 equivalent value for YA substitution purposes.
