This is to inform you that the Federal Crop Insurance Corporation's (FCIC) Board of Directors (Board) will hold a Board meeting July 31, 2003 from 1:00 p.m. to 5:30 p.m. EST, in Room 221-A, and August 1, 2003, from 10:00 a.m. to 3:30 p.m. EST, in room 104-A, Jamie Whitten Federal Office Building, U.S. Department of Agriculture, Washington, D.C.

This meeting is primarily to permit submitters of private insurance products under section 508(h) of the Federal Crop Insurance Act (Act) to make their presentations to the Board and for the Board to determine whether the submissions are ready to be sent out for expert review, and to permit submitters of private insurance products under section 508(h) of the Act to discuss with the Board the reports of the expert and other reviewers and for the Board, based on those review reports, to determine in Open Session whether their submissions should be approved or disapproved for implementation and reinsurance. Section 508(h)(4)(A) of the Act requires the FCIC Board to maintain the confidentiality of section 508(h) submissions until such time as the Board approves the submission. Therefore, the first order of business of the FCIC Board will be to go into Executive Session and no person from the general public, except those associated with the submission being discussed, will be permitted in the room.

The FCIC Board will conduct an Open Session of the meeting that will commence at approximately 1:00 p.m. on August 1, 2003, to address those matters specified in the Open Session portion of the attached Agenda. All members of the public are invited to attend this Open Session with the understanding that if a need arises for the Board to go into Executive Session at any given time, no person from the general public, except those persons designated by the Chairman of the Board, will be permitted to remain in the room.

Please note that the items listed on the agenda and the date, time and location of the meeting are subject to change without further notice.
