SUBJECT: Pasture, Range, and Forage Consultation

# **BACKGROUND:**

The Agricultural Risk Protection Act of 2000 (ARPA) authorizes the Federal Crop Insurance Corporation (FCIC) to enter into contracts for research and development to increase participation in States, areas, and agricultural commodities that are underserved by the Federal crop insurance program. ARPA directs FCIC to establish the development of a pasture, range, and forage program as one of the highest research and development priorities. ARPA also provides that, before entering into a contract for the above purpose, FCIC shall consult with groups representing producers of agricultural commodities that would be served by the policies that are the subject of the research and development.

The Risk Management Agency (RMA) has, in the past, consulted with producers and producer groups in conducting research into the development of insurance programs, some of which may include aspects related to pasture, range, and forage. The purpose of this Informational Memorandum is to formally begin the consultation process with groups representing pasture, range, and forage producers, consistent with the above-stated provisions of the Act.

## **ACTION:**

RMA is seeking input from groups representing pasture, range, and forage producers so their issues, concerns, and input will be considered before entering into a contract for the research and development of a pasture, range, and forage insurance program. The input of producers and their representatives is critical in determining the need and direction of research and potential

development. Of particular interest is any input that would be helpful for RMA to
