SUBJECT: Nutrient Best Management Practice Endorsement to Crop Revenue Coverage and

Multiple Peril Crop Insurance Materials Available

BACKGROUND:

On December 12, 2001, the Federal Crop Insurance Corporation's (FCIC) Board of Directors approved the Nutrient Best Management Practice (N-BMP) endorsement which was submitted by the Agricultural Conservation Innovation Center (ACIC) of the American Farmland Trust. The endorsement can attach to an underlying Crop Revenue Coverage (CRC) or Multiple Peril Crop Insurance (MPCI) policy.

The N-BMP endorsement is available in all counties in Iowa, Minnesota, Pennsylvania and Wisconsin for non-irrigated corn grown for grain. N-BMP provides insurance protection from crop production loss when a producer applies a rate of fertilizer (nitrogen, phosphorus or both) for maximum crop yield as recommended by a Best Management Practice (BMP). A certified crop consultant will recommend a BMP for the production area and crop to determine the amount of nitrogen and/or phosphorus to apply.

Producers interested in N-BMP should contact their crop insurance agent. The premium rate per acre, for the available States of Iowa, Minnesota, Pennsylvania and Wisconsin, is listed in the Actuarial Data Master record type K.
