SUBJECT: Addendum to 2004 Crop Year (CY) Actuarial Document (Special Provisions) - Crop Revenue Coverage (CRC), Group Risk Income Protection (GRIP), Income Protection (IP), and Revenue Assurance (RA) Harvest Price Announcements

CROP REVENUE COVERAGE

The following 2004 CY harvest prices have been approved for CRC corn, grain sorghum, and soybeans in counties with a cancellation date prior to March 15 and for CRC rice counties with a January 31 cancellation date.
