## **Rice (0018)**

# No Type Specified (997) and Long Grain Type (453)

Projected price - The harvest year's average daily settlement price for the projected price discovery period for the harvest year's futures contract, as shown in the tables below, rounded to the nearest one-tenth of a cent. The projected price will be released no later than three business days following the end of the projected price discovery period.

Harvest price - The harvest year's average daily settlement price for the harvest price discovery period for the harvest year's futures contract, as shown in the tables below, rounded to the nearest one-tenth of a cent. The harvest price will be released no later than three business days following the end of the harvest price discovery period.

## **Rice (0018)**

#### Medium Grain Type (452) and Short Grain Type (451)

Projected price – The no type specified/long grain type projected price as determined above, multiplied by a medium grain type/short grain type price factor determined by RMA, rounded to the nearest one-tenth of a cent. The factor will be available in the Price Discovery Reporting application located at <u>http://www.rma.usda.gov</u>. The method used for calculating the factor will be available at <u>http://www.rma.usda.gov/pubs/</u>. The medium grain type and short grain type projected prices will be released no later than three business days following the end of the rice projected price discovery period.

Harvest price – The no type specified/long grain type harvest price as determined above, multiplied by the same medium grain type/short grain type price factor determined for the medium grain type and short grain type projected prices, rounded to the nearest one-tenth of a cent. The medium grain type and short grain type harvest prices will be released no later than three business days following the end of the rice harvest price discovery period.

## **Rice (0018)**

## **Organic (Certified) Practice**

Projected price – The no type specified/long grain type projected price *or* medium grain type/short grain type projected price as determined above, multiplied by an organic practice price factor determined by RMA, rounded to the nearest whole cent. The factor will be available in the Price Discovery Reporting application located at <a href="http://www.rma.usda.gov">http://www.rma.usda.gov</a>. The method for calculating the factor will be available at <a href="http://www.rma.usda.gov/pubs/">http://www.rma.usda.gov/pubs/</a>. The organic (certified) practice projected price will be released no later than three business days following the end of the rice projected price discovery period.

Harvest price – The no type specified/long grain type harvest price *or* medium grain type/short grain type harvest price as determined above, multiplied by the same organic practice price factor determined for the organic (certified) practice projected price, rounded to the nearest whole cent. The organic (certified) practice harvest price will be released no later than three business days following the end of the rice harvest price discovery period.
